Message from the President ~ Martha Reid

It is the start of a new year and with that comes a renewed energy to set new goals, affect change, and help move us forward in our mission. I am humbled that I have been given the honor to lead the New York State Council this year as President and am excited to work with both our Execute Board and our membership to promote Emergency Nursing, Safe Patient Care, and advocate for our patients and ourselves. Our state council is stronger and more motivated than ever, and we are already off to a great start.

Late last year, we voted on two things that have already had an impact on 2018 and have gotten us jumpstarted forward already. First, we voted that we would offer all our 2018 Officers the opportunity to attend State and Chapter Leadership Orientation (SCLO). This is a wonderful opportunity to help both inform and grow new leaders as well as to energize and redefine and energize more seasoned leaders. We also encouraged all the NYS Chapters to consider sending representatives



as well. January 18-20 eleven of us met in New Orleans for SCLO, along with 300 other Emergency Nursing Leaders from all over the US and even beyond. Despite cancelled and delayed flights, boil water advisories, and severe cold that basically shut down the city of New Orleans, it was a very successful event and we all brought back new ideas and new energy for the upcoming year. The second thing that we had agreed upon for the upcoming year, is to actively promote the National Stop the Bleed campaign as our Injury Prevention initiative for 2018. To assist our chapters in this endeavor, the New York State Council purchased training kits for each state, an investment of more than \$1000 per kit. January 27, we held our annual orientation session in Binghamton for new officers and members and provided one more train the trainer Stop the Bleed session. At our state council meeting the next day, we asked the local Channel 12 news come and do a story to help to let the public know about this important training. I am excited to see how NYS ENA members can join with other healthcare professionals to help to educate the public in this important lifesaving skill. We have many other activities underway for this year, such as our annual Setting the Pace conference in Saratoga Springs April 19-20, Day on the Hill May 5 and work has begun on our new strategic plan to help guide us for the next few years as well. It is surely going to be an exciting and busy year and I invite you all to join us in making Emergency Nursing stronger, whether it be at the local, state or national level.

25 more people participated in the "Stop the Bleed" campaign on Friday before the State meeting. The State also handed out Stop the Bleed training kits for all of the chapters. These Kits cost \$1000 and were donated to the chapters from NYS ENA to continue the efforts of teaching Stop the Bleed in the communities of NYS.

Channel 12 came from the area and interviewed our President Martha Reid, Mary Ann Teeter, and Suzanne Bakiewicz from Herkimer Industries. They explained the importance of the Stop the Bleed campaign, how the kits will be used, who makes the kits, and where to obtain more information on the campaign.

Stop the Bleed day is March 31. Consider planning an event for your community in the spring.

Remembering . . .

The Genesee Valley Chapter received their original chapter charter (chapter code 020) in the early 1970's along with eleven other state chapters and became the first ENA chapter in New York State. The chapter initially represented emergency nurses from 13 hospitals in Monroe, Wayne, Livingston, and Ontario Counties. The organization and chapter were



supported by area emergency nurses, EMS and physicians. Dr. David Kluge, a general surgeon at The Genesee Hospital, was active in early trauma and highway

safety initiatives. He encouraged emergency nurses to meet and is considered the "founding father" of the chapter.

The chapter area has a long and rich history with ENA. The Emergency Room Nurses organization on the east coast and the Emergency Department Nurses Association on the west coast joined forces and the Association was initially incorporated as the Emergency Department Nurses Association (EDNA) in Rochester, NY on December 1, 1970.

Genesee Valley Chapter ENA was deactivated by in July 1983 due declining membership and membership involvement. In 1984, a group of emergency nurses at Rochester General Hospital under the leadership of Angela Karnes, RN, BS, contacted National ENA in an attempt to reorganize the chapter. A group of 7 nurses met, reorganized the chapter, elected officers and delegates and petitioned National ENA to reactivate the chapter. National ENA granted a second charter to the chapter in November 1984 with chapter code # 276. The chapter members began to attend the NYS ENA meetings in 1985 in Binghamton, NY and the National ENA Conferences as delegates representing the nurses of the region. Chapter dues were set at \$25. The monthly chapter meetings were held at Rochester General Hospital and as membership increased from area hospitals, the meetings were rotated between the area hospital emergency departments. This change in venue attracted more nurses to join the organization and the membership numbers quickly increased. Since 1984, the chapter membership has steadily grown and maintains representation from all area hospitals. The NYS ENA newsletter was published in Rochester in the 1990's and the state PO Box remains in Rochester. The chapter has a long standing association with the NYS ACEP whose offices are located now in Webster, NY. Three NYS ENA conferences were held in Rochester in 1992, 2009, and 2015. The Board of Certification for Emergency Nursing (BCEN) has maintained a testing site in Rochester since the 1980's.

The chapter has been in the forefront of education for emergency nurses. Local chapter member Suzanne Wall attended the first TNCC Instructor Course in 1985, returned from the National Conference and began teaching TNCC provider courses in the region. Janice Rogers, from the Pediatric Emergency Department at the University of Rochester, was instrumental in developing the curriculum for the first ENPC courses in 1991-1992.

Several NYS ENA Presidents have been members of the chapter including Virginia Hebda, Susan Chalupa-Breese, Susan Knapp, Mary Ellen (Mel) Wilson, and Gwen Williams. Mel Wilson went on to become the National ENA President. Local chapter members have served on both State and National Committees/Task Forces including Communications, Education, Government Affairs, Professional Development, Advanced Practice and Advocacy. Local chapter members are also involved in professional community organizations including the Monroe-Livingston Regional EMS Council, Regional Emergency Advisory Council, Study of Trauma and Emergencies Project (STEP) and the Alliance of Professional Nursing Organizations.

The chapter has developed a robust website under the direction of Gray Goose Graphics, Sue Chalupa Breese, Dawn McMullen and Tammy Ophardt. Chapter members are kept informed of activities and ENA updates through the website and Constant Contact.

In 2009, Sue Chalupa Breese, NYSENA president also began the ENA NY State website using Grey Goose Graphics.

Currently, the chapter has 190 active members. The chapter officers represent area 11 hospitals and facilities that impact emergency nursing in the region. In 2018, the chapter will sponsor 5 TNCC courses, 1 ENPC course, a Trauma Certified Registered Nurse (TCRN) Review Course and a Certified

Emergency Nurse (CEN) Review Course. A Certified Pediatric Emergency Nurse (CPEN) is planned in collaboration with Rochester General Hospital with Sue Chalupa Breese being the instructor. 1 ENPC instructor course and 1 TNCC instructor course is being offered in 2018. Chapter business meetings are held on the 2nd Monday of the month at Gates Volunteer Ambulance at 1700. Educational sessions are planned for every other month following the chapter business meetings. Chapter income, from dues and courses, support initiatives that include scholarships to the annual NYS Conference in April and the Emergency Nurses Day celebration in October.
